(a) **PP&L, INC. COMPETITIVE TRANSITION CHARGE (CTC) ANNUAL RECONCILIATION STATEMENT.**

(b) On December 1, 1999, pursuant to the Commission's Order of August 27, 1998 at R-00973954 and PP&L, Inc.'s electric service tariff, PP&L filed its first annual CTC reconciliation statement. In accordance with the provisions of 66 Pa. C.S. § 1307(e), this statement will be subject to public hearings held prior to January 29, 2000. Revised CTC rates reflecting the CTC reconciliation statement are to be filed within three days of December 16, 1999.

(c) The staff recommends:

- that PP&L, Inc.'s CTC reconciliation statement filed December 1, 1999, be accepted subject to public hearing held pursuant to 66 Pa. C.S. § 1307(e)
- that PP&L be directed to file, within three days of today's date, a tariff supplement implementing revised CTC rates to be effective January 1, 2000, reflecting the Company's CTC undercollected position as of December 31, 1999
