#### Gentlemen:

This letter is written in support of the application of Mr. Earhart for emergency temporary authority and regular temporary authority. We understand that the shipper support letter must contain certain information, which we are submitting as follows:

- 1. We are in the coal business and the only commodity involved in this application is coal.
- 2. Mr. Earhart currently has authority at A.65936, F.3, to transport coal (and other commodities) between points in the counties of Indiana, Westmoreland, Armstrong and Allegheny, provided no haul shall exceed a distance of 35 miles from point of origin to point of destination.
- 3. We have been using this service for 14 years and are very pleased and satisfied with his service. Our payments to Mr. Earhart are approximately \$60,000 a month. We do not operate any trucks of our own and rely on him for our deliveries.
- 4. We do not use any other carrier for the transportation involved in this case because we have relied on Mr. Earhart for the bulk of our delivery service. We formerly had trucks of our own which we sold and disposed of about five years ago.
- 5. We understand that there has been a road check in which a truck was delivering to Blairsville, in Indiana County from Cambria County. Cambria County is not included in the present rights of Mr. Earhart and we request the Commission to approve the right to deliver coal from Cambria County to not only Indiana County, but to Jefferson and Clearfield Counties as well. In other words, the rights should read, "To transport coal for North Cambria Fuel Company from its mines and tipples in the counties of Cambria, Jefferson, Indiana and Clearfield to other points in said counties." This would clear up the matter once and for all and would satisfy our needs.
- 6. The problem we have is that we operate mines and tipples and we also purchase coal from other producers. We have recently begun to ship coal from Cambria County, which we have never done before. The current point of origin is near Johnstown in Lower Yoder Township, but we do not want him limited to the one point of origin

because we are seeking to purchase coal and mine coal in other parts of Cambria County.

- 7. With respect to existing carriers, the answer is we have not contacted other carriers about this work because, first of all, we do not know who to contact or what kind of service, if any, they could provide. The kind of service which we get from Mr. Earhart consists of having a truck dispatched immediately when called and having the coal picked up at the earliest possible time and sent on its way. We cannot depend on service from a carrier where we have to give him one day's notice because the coal has to be transported from our origin points to cracking plants where the coal is blended for shipment to suit the specifications of the purchaser. All of this transportation has to be coordinated so that the deilvery, the blending and the final delivery is accomplished without delay. All of our deliveries are made under contracts where we have strict time requirements for delivery. The coal is taken to trains in Blairsville where it is hauled by rail to Philadelphia. Delays in transportation to Blairsville would cause the trains to be late and would put us in the position of violating our contract.
- 8. The revenue involved in the additional service which we are asking the Commission to approve is approximately \$10,000 a month, over and above what Mr. Earhart charges us for the other service he provides.
- 9. We hope the Commission does not force us to try to seek out other carriers because years ago we did experiment with other carriers and finally had to get our own vehicles due to the nature of the service we require. After we started using Mr. Earhart, we were able to rely on him, so we could dispose of our own trucks. We are afraid that if the Commission does not approve this immediately, we will be forced to going back to buying or leasing our own equipment, which we would definitely not like to do. As a practical matter, we do not know of any carrier that has the rights to transport in Cambria, Jefferson, Indiana and Clearfield Counties, which we require. The main movement is from Cambria County to Blairsville, Indiana County, but we anticipate shortly, asking the applicant to serve us from Clearfield and Jefferson and Indiana County origin points as well. As we have said above, we cannot predict where the coal will move from due to the nature of the business.
- 10. We need service six days a week, Monday through Saturday (year round). There are 20 truckloads a day from the points not presently authorized.
- 11. We anticipate that the need for service will continue for years. We have used Mr. Earhart for 14 years now and believe that his service will be required indefinitely into the future.
- 12. If the Commission does not grant emergency and regular temporary authority to Mr. Earhart, the consequences to our company will be very severe. We are not asking Mr. Earhart to perform illegal service and we do not ask any carrier to do this. Since he already has a certificate which covers the bulk of our needs, the additional territory which we are asking the Commission to grant him should be approved in order to give us a complete and total service. It would not be business like or even feasible for us to use Mr. Earhart for the bulk of our transportation and then have to rely upon other carriers for the additional service which we require. We feel that this would be very impractical and would not be to our benefit. We use Mr. Earhart as our primary carrier and we feel that he should have all of the authority which he needs to serve us legally.

#### Gentlemen:

This letter is written in support of the application of Mr. Earhart for emergency temporary authority and regular temporary authority. We understand that the shipper support letter must contain certain information, which we are submitting as follows:

- 1. We are in the coal business and the only commodity involved in this application is coal.
- 2. Mr. Earhart currently has authority at A.65936, F.3, to transport coal (and other commodities) between points in the counties of Indiana, Westmoreland, Armstrong and Allegheny, provided no haul shall exceed a distance of 35 miles from point of origin to point of destination.
- 3. We have been using this service for 14 years and are very pleased and satisfied with his service. Our payments to Mr. Earhart are approximately \$60,000 a month. We do not operate any trucks of our own and rely on him for our deliveries.
- 4. We do not use any other carrier for the transportation involved in this case because we have relied on Mr. Earhart for the bulk of our delivery service. We formerly had trucks of our own which we sold and disposed of about five years ago.
- 5. We understand that there has been a road check in which a truck was delivering to Blairsville, in Indiana County from Cambria County. Cambria County is not included in the present rights of Mr. Earhart and we request the Commission to approve the right to deliver coal from Cambria County to not only Indiana County, but to Jefferson and Clearfield Counties as well. In other words, the rights should read, "To transport coal for North Cambria Fuel Company from its mines and tipples in the counties of Cambria, Jefferson, Indiana and Clearfield to other points in said counties." This would clear up the matter once and for all and would satisfy our needs.
- 6. The problem we have is that we operate mines and tipples and we also purchase coal from other producers. We have recently begun to ship coal from Cambria County, which we have never done before. The current point of origin is near Johnstown in Lower Yoder Township, but we do not want him limited to the one point of origin

because we are seeking to purchase coal and mine coal in other parts of Cambria County.

- 7. With respect to existing carriers, the answer is we have not contacted other carriers about this work because, first of all, we do not know who to contact or what kind of service, if any, they could provide. The kind of service which we get from Mr. Earhart consists of having a truck dispatched immediately when called and having the coal picked up at the earliest possible time and sent on its way. We cannot depend on service from a carrier where we have to give him one day's notice because the coal has to be transported from our origin points to cracking plants where the coal is blended for shipment to suit the specifications of the purchaser. All of this transportation has to be coordinated so that the deilvery, the blending and the final delivery is accomplished without delay. All of our deliveries are made under contracts where we have strict time requirements for delivery. The coal is taken to trains in Blairsville where it is hauled by rail to Philadelphia. Delays in transportation to Blairsville would cause the trains to be late and would put us in the position of violating our contract.
- 8. The revenue involved in the additional service which we are asking the Commission to approve is approximately \$10,000 a month, over and above what Mr. Earhart charges us for the other service he provides.
- 9. We hope the Commission does not force us to try to seek out other carriers because years ago we did experiment with other carriers and finally had to get our own vehicles due to the nature of the service we require. After we started using Mr. Earhart, we were able to rely on him, so we could dispose of our own trucks. We are afraid that if the Commission does not approve this immediately, we will be forced to going back to buying or leasing our own equipment, which we would definitely not like to do. As a practical matter, we do not know of any carrier that has the rights to transport in Cambria, Jefferson, Indiana and Clearfield Counties, which we require. The main movement is from Cambria County to Blairsville, Indiana County, but we anticipate shortly, asking the applicant to serve us from Clearfield and Jefferson and Indiana County origin points as well. As we have said above, we cannot predict where the coal will move from due to the nature of the business.
- 10. We need service six days a week, Monday through Saturday (year round). There are 20 truckloads a day from the points not presently authorized.
- 11. We anticipate that the need for service will continue for years. We have used Mr. Earhart for 14 years now and believe that his service will be required indefinitely into the future.
- 12. If the Commission does not grant emergency and regular temporary authority to Mr. Earhart, the consequences to our company will be very severe. We are not asking Mr. Earhart to perform illegal service and we do not ask any carrier to do this. Since he already has a certificate which covers the bulk of our needs, the additional territory which we are asking the Commission to grant him should be approved in order to give us a complete and total service. It would not be business like or even feasible for us to use Mr. Earhart for the bulk of our transportation and then have to rely upon other carriers for the additional service which we require. We feel that this would be very impractical and would not be to our benefit. We use Mr. Earhart as our primary carrier and we feel that he should have all of the authority which he needs to serve us legally.


