

RESPONDENT DUQUESNE LIGHT COMPANY'S MOTION FOR EXTENSION OF TIME

TO THE HONORABLE COMMISSION:

AND NOW comes Respondent, Duquesne Light Company, by and through its attorneys, Tucker Arensberg, P.C., pursuant to 52 Pa. Code §5.103, respectfully petitions this Honorable Commission to grant Respondent an extension of time to file its Replies to Exceptions, for the following reasons:


1. Complainant filed Exceptions that were postmarked on July 22, 2013.
2. The exceptions were not timely filed. The parties were advised via Secretarial Letter dated June 27, 2013 that Exceptions must be filed within twenty days of the date of the letter, which was July 17, 2013.
3. The Secretarial Letter of June 27, 2013 also advised the parties that Replies to Exceptions must be filed within ten days of the date when Exceptions are due, which is July 27, 2013.
4. If the Exceptions had been timely filed, then Respondent would have had at least ten days to prepare its Reply Exceptions.

5. If Respondent is required to file Reply Exceptions by July 27, 2013 (effectively July 29, 2013, the first business day after the deadline), Respondent will be prejudiced by the abbreviate of time it has to file its Exceptions.
6. Ten days from the date that Complainant's Exceptions were postmarked is August 1, 2013.

WHEREFORE, Respondent, Duquesne Light Company, respectfully requests that the Honorable Commission grant Respondent an extension of time until August 1, 2013 to file its Replies to Complainant's Exceptions.


