I know I am 82 years old and have worked for anything I ever got for as long as I can remember. I still work a full week when I am able to. I have never taken advantage against anyone, that I know of. It is a little harder to work now, because I have a bad problem with aches + pain from the left side of my lower back, in my buttocks, down my leg, front and back, and to my toes. This takes a lot of my time. I have all kinds of doctors, x-rays, therapy, even 3 shots in 3 months for pain and aches. Doctors do not know the cause, they say maybe nerve problem, but I still have to live with it. I am only mentioning this because this was the cause for asking you for my 1st extension. I am not mentioning this for you to feel sorry for me. It is not an excuse. It is a fact. I have 5 children. They all pitched in and paid for me to go and rest in Florida, under the sun and try to heal. It helped a lot.

I missed the day of the hearing June 5<sup>th</sup> because in my haste, I wrote on my calendar June 25<sup>th</sup>

You went way beyond the call of fairness for me. You even called me on the day of the hearing to give me a chance. You left a message on my voicemail. I was having trouble with my phone and while the phone got straightened <sup>out</sup> I didn't have voicemail for approximately 2 weeks. Occurrences have not been going my way.

I filed a legal complaint against D.L. at the local <sup>②</sup> Magistrate. The magistrate gave me a fair hearing. He did not want to make a decision so he dismissed the case without prejudice. (I don't blame him, he was fair.)

I appealed this case to arbitration. As you know, sometimes you do not get a fair hearing. This wasn't fair. I should just give in, pay the improper fine of 300. <sup>③</sup> H.E. Electricity and move on as I did before. The arbitrators made an absolute fool out of me.

I have appealed this case to Common Pleas. Here we have a real judge and a real court reporter taking testimony. It should be different there. My father taught me a long time ago. "No matter what the odds, if you are right, you must at least try, otherwise you can't succeed."

Your Honor, the only reason I am filing exceptions is because the letter says so. I could not file exceptions against you. Everything you did was right.

I am writing this to let you know, even if you rule against me, you have earned that right. I just want ~~you~~ to know, I appreciate all you have done.

Your Honor, I am pursuing this case because my reputation has been impaired and DL and its agents have deprived me of my right to make a living by not providing me electrically to fulfill my investment because they are the only game in town.

For some reason the person who wrote this notice did it improperly and DL is backing him up by punishing me and distorting with him the process. By doing this they are distorting and spending a lot of stock market money to pursue a frivolous action. It is the big guy against the little guy.

I am enclosing a copy of the notice D.L. agent Mr Roberson taped to my door. This notice started the action and disturbed me greatly. This notice says what it is written. This is it, in its entirety. It is not what lawyers say it means. They don't write words and make a charge and say it means something else. They tried to distort and punish me. I never could figure out why? Until I found out who took this action. Mr. Roberson. I have had a few altercations with Mr. Roberson before. I lost them all. He is big shot with the power and muscle. He can shut you off, make you pay, right or wrong, there is no appeal.

the only thing I did wrong was to own the property. When I bought it, it was vandalized, no plumbing or electricity, fixtures and everything else. Electricity was turned off for many years. There was no wire coming from pole to house, the wire was cut by DL and hanging, no power.

D.L. distorted the report sent to the P.U.C. I never could figure out why D.L. would spend all this money, all this time, all this manpower, who they pay, in a hour or two what this 300<sup>00</sup> would pay that they tried to fine me then say it wasn't a fine. Finally, I say maybe the power of Mr Robinson. He is power of Judges & Jury. No Appeal. I tried and made complaints to have Mr Robinson reprimanded. I failed, he beat me. If I wanted electricity, I had to pay + move on. I did. I don't even remember the cases anymore. I keep wondering why?? Someone wants me all full bad.

I am going to show a couple exhibits:

- 1. they call this shut off notice: this is why I took exception.  
 "Electric has been shut off. Not true. - Electric power had not been hooked up for several years before I bought house. this notice says Electric shut off 4-15-10. Not true.
- 2 Accused me of meter tampering, and say I stole electricity. How + Why? There never was any.
- 3 Unsafe Condition How?? What was unsafe.
- 4 Pay an investigation fee of 400.00 + that is the written fine, Not Oral. Now DL is lawyered up and all

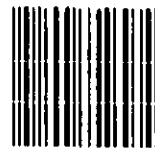
