36-1961 Unopened ways - Any street, lane, or alley laid out by any person or persons in any plan of lots on land owned by such person or persons that has not been opened to or used by the public for 21 years next after the laying out of same, shall be and have no force and effect and shall not be opened without the consent of the owners of the land on which the same has been or shall be laid out. This is no township street, roadway or alley, no valid easement or right of way. If dedication is not perfected within 21 yrs. this section extinguishes the public right to road. Public right is foreclosed and when side of street is called for as boundary in a deed granted takes title in fee to the center of the street by operation of law, terminating all right of public in platted street.

Citizen P. am Water deed, of easement and right of way was granted having good title to do so by owners of land in 1960 giving a 40 ft. wide unobstructed right of way and easement - the 40 ft. unopened street in Barnister Pland of Lots, Jan. 1931 - all public rights ending (+ 21) in 1952.

Columbia's gas line is not constructed in any street, roadway or alley, but was laid without a legal permit right of way or easement in area that is an exclusive water easement secured by good title for the transportation & distribution of water, only. Public Utility 65.18 appropriate easement.

The P.U.C. regulates and investigates utilities for the public good: setting standards & penalties for individuals, firms, corporations, the execution of unlawful contracts written or verbal and the failure to obey, observe or comply with any regulations.

My removal from my own private property by Columbia Pa State Police as they excavated without permit, right of way, permission - trespassing on land that the public right is foreclosed, extinguished, for didden, is reason enough to hear this case. The Wash Co. Clerk of Courts (724-228-6767) will make available an internet video hearing which I request.
