Re: Request to modify License of Stand Energy Corporation, No. A-125103 Issued 9/25/2002, Amended 9/8/2003 and 8/21/2008

Dear Secretary Chiavetta,

In 2002 Stand Energy Corporation was issued a license to supply natural gas to commercial and industrial customers in the Pennsylvania service territories of Columbia Gas of Pennsylvania and Dominion Peoples. Later amendments in 2003 and 2008 added the additional service territories of Equitable Gas Company and the National Fuel Distribution Company. Stand Energy now would like to further amend the license to add the Pennsylvania service territory of Peoples TWP LLC.

In compliance with the Commission's requirements, we have received from Peoples TWP a letter indicating that Stand Energy Corporation is not required to provide any security or credit enhancement at this time. It is still Stand's intent to serve only commercial, governmental and industrial customers. Stand Energy will not be marketing to residential customers behind Peoples TWP or any other Pennsylvania utility.

Please ask the Pennsylvania Utility Commission to make the requested amendment to our license. If further information is needed please contact me at the above contact information or by email to mward@stand-energy.com.

This letter serves as notification that Peoples TWP LLC does not require Stand Energy Corporation to provide a security or credit enhancement at this time. Our decision is based on the fact that your company is not currently operating, and has no immediate plans to operate, a Non-Priority One Pool or a Priority One Pool on the Peoples TWP system. However, if in the future your company desires to establish a Non-Priority One Pool or a Priority One Pool on the Peoples TWP system, it may be required to establish a security or credit enhancement based on the terms set forth under Paragraphs 19 and 20 of the Rules and Regulations of the Peoples TWP Tariff.


