

 - (a) Complainant, Howard Johnson, Jr., and Respondent, PPL Electric, agree that commencing with the bill due August 2013, Complainant will pay his budget bill plus \$15.00 per month towards arrearages until all arrearages are paid in full. So long as timely monthly payments are made, Respondent will not apply late fees or penalties.
 - (b) Complainant withdraws his Complaint.
