



 - (a) Complainant, Michael Scotto, and Respondent, PPL Electric, agree that Complainant has been enrolled in the OnTrack customer assistance program, and that Complainant's OnTrack monthly payment amount will be \$59.00, beginning with Complainant's next issued bill. Complainant and Respondent further agree that the due date for Complainant's monthly bill has been changed to the 15th day of each

month. Complainant and Respondent further agree that Respondent will send Complainant an application for the WRAP customer assistance program.
