



(a) Complainant, Darnell Hymans, and Respondent, PPL Electric, agree that Complainant will make a payment of \$231.00 to Respondent by August 30, 2013. Complainant and Respondent further agree that Complainant will subsequently pay his regular monthly bill plus \$50.00 per month toward arrearages, until all arrearages are paid in full, beginning with Complainant's September 2013 bill.

(b) Complainant agrees to withdraw his Complaint.


