Response:

The PA Department of Revenue will be notified at the time the final corporate tax return is filed. Supplier will file the final corporate tax return after the *LLC Conversion* has been completed. Prior notice is not required to be given to the PA Department of Revenue before the final corporate tax return is filed.

To complete the *LLC Conversion*, a certificate of merger (evidencing the merger of UGIES, Inc. into UGIES, LLC) and a certificate of dissolution (evidencing the dissolution of UGIES, Inc.) will be filed with the PA Secretary of State. Supplier will complete the *LLC Conversion* promptly after it receives the Commission's approval of the above-captioned petition and the *Petition of UGI Energy Services, Inc. for Approval to Transfer the Natural Gas Supplier License of UGI Energy Services, Inc. to UGI Energy Services, LLC*, at Docket No. A-125018 and A-2013-2369286.

Data Request:

Response:

With respect to notice to its customers of the LLC Conversion, Supplier sent written notice to all of its retail customers in Pennsylvania during the week August 5, 2013. A copy of the template notice, which was reviewed and approved by the Bureau of Consumer Services, is attached hereto as Exhibit TUS I-5(A).

With respect to notices sent to the electric distribution companies ("EDCs") (which, in Pennsylvania, the EDCs are the providers of last resort), Supplier has sent two separate notices. First, Supplier served a copy of the above-captioned Petition on each EDC on May 3, 2013, as evidenced by the Certificate of Service attached to the Petition.

Additionally, Supplier sent a separate written notification, on July 31, 2013, to the EDCs where Supplier currently operates ("EDC Notice"), which includes the following:

- Duquesne Light Company
- Pennsylvania Power Company (Penn Power) FirstEnergy Company
- Metropolitan Edison Company (Met-Ed) FirstEnergy Company
- Pennsylvania Electric Company (Penelec) FirstEnergy Company
- West Penn Power FirstEnergy Company

- PECO Energy Company Exelon Company
- UGI Utilities, Inc. Electric Division

In the EDC Notice, Supplier (1) provided notice of the *LLC Conversion* and of the above-captioned Petition, and (2) sought each EDC's consent to assignment of any existing supplier coordination, electronic data interchange, billing services and/or purchase of receivables agreements from UGIES, Inc. to UGIES, LLC. The EDC maintains copies of all such agreements. Supplier is currently in the process of obtaining such consents to assignment from the EDCs. Supplier will notify TUS once it has received all of the necessary consents from the EDCs and provide a copy of such consent.

After the *LLC Conversion* is completed, Supplier will need to provide the EDCs with its new DUNS number for purposes of EDI transactions.

Other than as stated above, Supplier is not aware of any open issues regarding contracts, agreements or other arrangements which UGIES may have with any party under its EGS license that may affect the flow of electricity at retail.

Reliability First requires the submission of a Registration-Revision form after the LLC Conversion is completed, attached hereto as Exhibit TUS I-7(C).
