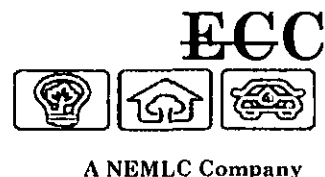

Dear Madam Secretary,

On January 28, 2013, PJM Wholesale Brokers filed an application with the Public Utilities Commission ("PUC") for an Electric and Natural Gas Broker License and was assigned the above captioned Docket Numbers.

On April 22, 2013, this office received correspondence dated 18 April from the PUC requesting additional information, which was provided shortly thereafter.

On March 27, 2013, PJM Interconnection LLC filed a letter dated March 18th, 2013 with the Commission, pertaining to the use of "PJM" within a Broker's name. Moreover, the Commission and Staff expressed concerns that Pennsylvania consumers may be confused due to the similarities in the corporate names, respectively.

After internal meetings on the subject, and in consideration on the Commissions concerns, PJM Wholesale Brokers decided to formally change its primary corporate name to US Grid Energy, LLC, which was duly registered with the Department of State and received its Certificate of Amendment (15 Pa. C.S. § 8585) dated 20 June, 2013.

US Grid Energy respectfully submits the following information and requests that the PAPUC approve the above captioned Docket No.'s under the Applicant's primary corporate name, US Grid Energy, LLC. At no time will Applicant use the name "PJM" in any further matters within the Commonwealth of Pennsylvania, including, but not by way of limitation, marketing materials, consumer outreach, or formal filings with the Commonwealth.

Throughout this process, this office has been in constant contact with Mr. Robert Young and Mr. Jim Shurskis of the PAPUC. We have requested, and been granted, an extension to have sufficient time to file and acquire the documents outlined below so that we may present such documentation to the Secretary.

Enclosed please find the following for your review and consideration: (*Exhibit A*)

1. Certificate of Amendment (15 Pa. C.S. § 8585) dated 20 June, 2013 formally changing the primary corporate entity to US Grid Energy, LLC
2. Affidavits of publication for both electricity and natural gas noting the formal name change and published in the designated newspapers.
3. Amended electricity bond (No. PB11499800125) in favor of the Pennsylvania Public Utilities Commission noting the change to US Grid Energy, LLC

Applicant, US Grid Energy, respectfully requests that the PAPUC accept the above documentation as a good faith effort to assuage the Commission's concerns and submits that the steps it has taken are sufficient to avoid any confusion on the part of Pennsylvania consumers.

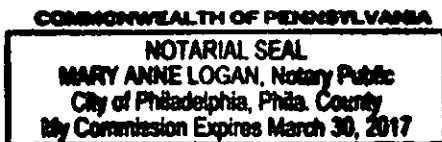

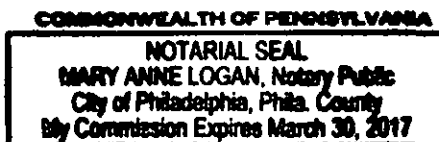

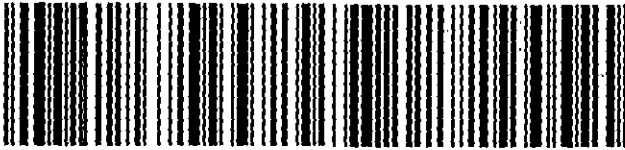
