PROTEST/PETITION TO INTERVENE OF RED LION MUNICIPAL AUTHORITY

NOW COMES Red Lion Municipal Authority (hereinafter referred to as "Red Lion"), by and through its undersigned counsel, and respectively submit this Protest to Part (2) of the above-captioned Application.

3. On or about April 21, 2001, The York Water Company ("York Water") filed an Application for Approval to begin to offer or furnish water and wastewater service to the public in a portion of Chanceford Township and Felton Borough, York County, PA, with the Pennsylvania Public Utility Commission ("Commission").

4. Notice of the Application was published in the Pennsylvania Bulletin on April 21, 2001.

5. Red Lion has water facilities and customers in Chanceford Township and is capable of serving any future water service in the Township. Therefore, Protestant Red Lion has a substantial interest in this proceeding.

6. The proposed new service found in part 2 of the application is contrary to the public interest in that it would authorize unnecessary service and harmful competition.

7. Red Lion hereby places at issue the feasibility of additional service in Chanceford Township by York Water.

WHEREFORE, Red Lion respectfully requests the Commission to:


(a) Dismiss the Application for new service in Chanceford Township as not necessary for the public commerce and necessity.

(b) Institute an investigation into the proposed merger and transfer of control;

(c) Assign the Application and this Protest to the Office of Administrative Law Judge for hearings and the issuance of a Recommended Decision; and

(d) Grant such further relief to Red Lion as may be appropriate upon consideration of the full evidentiary record developed at hearings.

As you know, when The York Water Company files a rate case, we file multiple paper copies of numerous volumes with each of the rate case parties.
