I am sending this letter in response to the complaint dated July 26, 2013, Docket Number C-2013-2370715. I had no knowledge of my non-compliance. All correspondence that had been sent to me I passed along to my insurance agent and believed all was corrected prior to this notice. Furthermore, at no time was there a lapse in my auto coverage

My insurance agent, Daniel Conville, located at 464 S Washington Street Eau Claire Pa, had rewritten my Commercial auto policy with a different Carrier effective for April 12, 2013. He in turn cancelled the prior policy with Progressive. He and I were totally unaware that the E-filing and H-filing had to be on the new policy. When I received the initial notice that these coverages needed to be present, I promptly notified Dan. He then in turn added the E-filing and attempted to add The H Filing and sent over proof of insurance. Unfortunately, the new insurance company did not offer the H-filing and this was never added.


