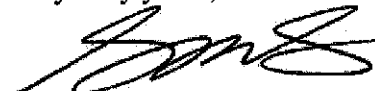

CERTIFICATE OF SATISFACTION

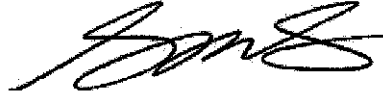
1. Complainant is Andrea Gordick.

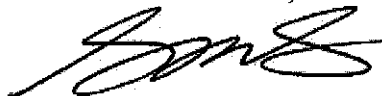
