Dear: Administrative Law Judge Marta Guhl,


I would like to apologize for me being late for our hearing July 12, 2013. Thus night July 11th my 13 year-old daughter broke her wrist, being thought I had to catch train from the hospital in NJ to Philadelphia that made me 30 mins late. Despite of the hardship Thursday night I and her mother Ms. Leonard were both trying to make it to court on time Friday but could not. I don't have a working phone so I had no way to call and let you know I was going to be late. Ms. Leonard had being calling PGW for the all last week prior to coming to court leaving many messages tying get information about the lien that PGW put on the property, no answer and no call backs. How was a lien put on her property when I'm the person who called and establish services not her if anything this bill that I'm disputing is my bill not hers.

Can you please give me another hearing date for this matter? I'm also asking if you can have the lien for my bill "that in legation" removed from Ms. Leonard property. She is not my landlord nor is I her tenant, we both work together to provide a safe and happy living for our children yes she owns the home but no one had been occupying the residence at the time where they are trying to back

charge me. Ms. Leonard and our daughter were living at 79 Prospectvillage Trenton NJ and I was in living in New York 09-11.

We never know a lien was on the house until the mortgage company contacted Ms. Leonard just recently explaining what was going on asking if she can have PGW subordinate the lien (for a bill that I'm disputing) in order for the company to make modifications to the mortgage. If the lien is not removed or subordinate by August 30th Ms. Leonard will not be illegible for the modification program and her house my home will go into foreclose because of an "estimated" bill PGW billing me for years of no was occupying the home. Now I'm here living in the home with my daughters there may be a chance of us being homeless. If I can get a hearing date before the end of August can you please remove and if there is an amount that I owe it can just be billed me until we can get this stuff settled.
