
On behalf of Atlas Transportation, Inc. ("Atlas"), I write to request that the PUC not consider the Protest filed by Mid-Atlantic Transportation Services, Inc. ("Mid-Atlantic") to Atlas' *Application for Motor Common Carrier of Persons upon Call or Demand (Taxi Service)* (the "Application"). The basis for this request is that the Protest filed by Mid-Atlantic is untimely.

All Protests to Atlas' Application were due on or before May 6, 2013. Mid-Atlantic failed to mail its Protest until May 8, 2013 and the PUC did not receive the Protest until May 9, 2013. A copy of the UPS Track and Confirm information for Mid-Atlantic's Protest is enclosed hereto evidencing the mailing date, as well as the date that the Protest was untimely received by the PUC. *Moreover, the Protest was improperly filed by the President of Mid-Atlantic, not by an attorney.* Thus, the Protest is clearly untimely and Atlas requests that the PUC kindly remove Mid-Atlantic's Protest from the docket and from consideration.
