Response to Misleading Answer

- ① History - 21 N. Front ST, M. ITM PA WAS THE former ELKS Lodge and I converted the 2<sup>nd</sup> & 3<sup>rd</sup> fls to (7) apts with individual GAS Service in 2007.
- ② at the beginning all Meters were in my name until the 1<sup>st</sup> Tenant occupied each apt and ALL (7) apts were occupied by Tenants.  
AT NO TIME did I give UGI Penn NAT GAS permission to put gas in my name. I know the drill since I own over 25 buildings in PA. once a Tenant moves UGI is happy to put the old bell in the landlord's name.
- ③ I never lived in this apt. The difference in the no. is initially PPL used 203 or 23 & UGI used a different name. It had something to do with the Post office charging the apt. #.
- ④ UGI's Collection agency are harassing Landlords by sending regulations that do not apply. I have dealt with UGI for years and my recently lost They started this behavior.
- ⑤ Mr Jeffrey Sunday in the last(2) dealing has shown himself to be deceitful to the Public Service Commission and unethical in his dealings with me

UGI has extractors on all my buildings that the gas is never to be put in my name and in the last 5 yrs have lived up to those instructions.

What Mr Sunday has done to decrease the Commission as gas back to the initial installator when all 7 acct. were in my name, & states gas acct # 906208907406 is my acct. There have been at least (4) Tenants in the apt since then.
