

  - (a) Complainant, Michael Quinn, and Respondent, PPL Electric, agree that Complainant currently has an outstanding balance on his account in the amount of \$1,111.14. Complainant and Respondent PPL further agree that Respondent will remove \$562.78 from Complainant’s account. Complainant and Respondent further agree that Complainant will pay the remaining account balance of \$548.36. Complainant

and Respondent further agree that Complainant will contact Respondent if Complainant needs to break this amount down into installments.

(b) Complainant agrees to withdraw his Complaint.
