
Section 10 – Service Area

This letter serves as notification that Peoples TWP LLC does not require Power Management Company, LLC to provide a security or credit enhancement at this time. 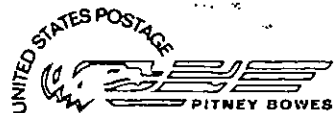
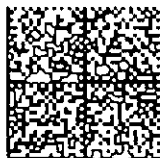
