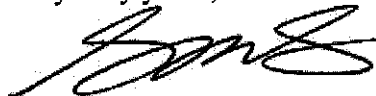

CERTIFICATE OF SATISFACTION

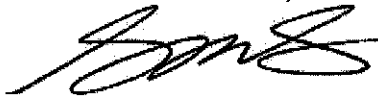
1. Complainant is Sharon Kay Stepp.

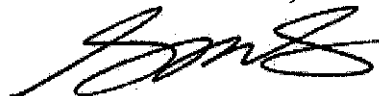
