Dear Chairman Powelson:

The Commission's order and opinion dated 8-15-13, is wholly rejected, it is fraught with errors .

1. You held a hearing on thr subject case without proper notice to me as required by the code.
2. HISTORY OF THE PROCEEDINGS - on 7-17-12 at 10 AM, a telephonic hearing was held, there was in fact, evidence presented , showing that DLC counsel failed to submit documents in a timely manner. The brain dead hearing officer did not reprimand the violator, apparently due to the rumored relationship between these two and he set a continued hearing for 9-26-12. On 1-15-11, I filed an informal, followed shortly thereafter, by a formal complaint with the PUC, concerning my inflated electric bill covering the period 12-10-10 to 1-10-11, and after protracted discussions, DLC's assistant chief legal counsel agreed with my contentions, that the meter was malfunctioning and that DLC would credit my account \$300 for that over billing. However, the over billings continued for the balance of 2012


This Commission's 8-15-13 order is incoherent.
