

Defendants Brief in Support of Answer to Complaint

Respondent in the matter is 903 Rentals Inc with offices at 1358 State Route 903, Jim Thorpe, and Pennsylvania.

The Respondent does not deny that Respondent failed to obtain a Criminal history record as required by 52 PA Code 29.505(a) Further, Respondent in its Capacity makes every effort to comply with all laws and regulations of the Commonwealth. This was an oversight by Carrier and corrected immediately upon notification of PUC Officer . As soon as carrier was notified by Officer Thomas Kepping a Pennsylvania State Police background check was immediately performed and results were immediately given to Officer Keeping.

Respondent failed to have consumer info information on vehicle as Respondent purchased a new vehicle and carrier did not have decals in possession at the time of inspection.

Officer Kepping subsequently forwarded Carrier Consumer Decals via US Mail.

Upon receipt of decals Respondent immediately placed decals upon vehicle. All violation that was brought to Respondent's attention has been corrected.

Respondent is a Small Size Carrier and the imposition of a three hundred (\$300) fine will place a financial burden upon Respondent.

Therefore, Respondent requests that either Complaint be dismissed and a written warning be issued to Respondent or a lesser fine be imposed upon Respondent.


