Wayne W. Sell Corporation holds operating authority from this Commission at Docket No. A-93415. Among the authority held at this docket is authority to transport property in bulk, in dump vehicles, between points within fifty (50) miles of the limits of the Borough of Homestead, Allegheny County, and from points in said territory to points in Pennsylvania, and vice versa. This carrier also holds authority to transport dry salt, in bulk in tank vehicles, from the facilities of Standard Terminals, Inc. located in the cities of New Kensington and Arnold, Westmoreland County, to points in Pennsylvania on and west of the eastern boundaries of the Counties of McKean, Cameron, Clearfield, Blair and Bedford. Wayne W. with right 20 above subject to the following conditions:

IT IS ORDERED: That the application, as amended, and as further limited, be and is hereby approved and that the certificate issued June 13, 1978, as amended, be further amended to include the following rights:

To transport, as a Class D carrier, coal, in bulk, from points in the counties of Clearfield and Centre, to points in the counties of Allegheny, Butler, Armstrong, Venango, Lawrence, Crawford, Indiana, and Erie;

with the above right subject to the following conditions:

- (a) That no right, power, or privilege is granted to render service to points in the counties of Armstrong and Indiana, except for T. G. Hickson, directly from strip mining locations.


