
I am requesting that the fine imposed in file # C-2013-2376709 be waived.

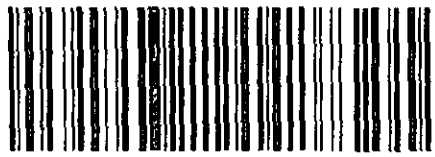

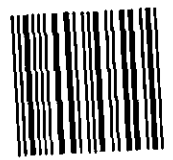
