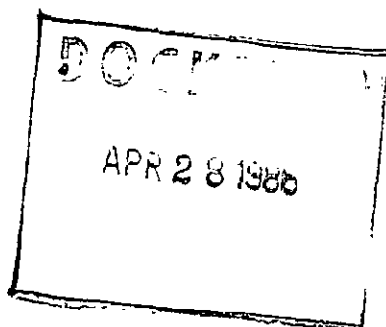

Dear Mr. Rich:

We represent Pitt-Ohio Express, Inc., the applicant in the above proceeding involving the proposed purchase of a portion of the intrastate operating authority of Breman's Express Company. This application is presently pending before Administrative Law Judge Larry Gesoff. The application which was originally opposed is now unopposed based on a letter dated April 24, 1986 from counsel for Newcomer Trucking, Inc. withdrawing that company's protest.

For a number of reasons, Pitt-Ohio Express, Inc. has reevaluated its position with respect to the proposed acquisition of the Breman's rights and has concluded not to proceed with the transaction.

On March 14, 1986 Pitt-Ohio assigned all of its right, title and interest in the purchase agreement with Breman's to Nicklaus Freight Lines, Inc., which assignment was approved by the Bankruptcy Court by order dated April 4, 1986.

Simultaneously with the delivery of this letter to the Commission, Nicklaus Freight Lines, Inc. is filing with the Commission an application to purchase the operating rights previously sought to be purchased by Pitt-Ohio.

Accordingly, Pitt-Ohio respectfully withdraws the above application.
