




The above-referenced application involves a very complex transfer proceeding. Review of the record has raised a question which the material before us does not appear to answer.

The transferor and transferee propose to fractionalize transferor's Folder 2 authority:

- (a) with the applicant to receive the right to render service from Allegheny County to the counties of Lancaster, Lebanon and Berks and vice versa, with the right to interchange with Class A, B & D carriers.
- (b) with the transferor to retain the right to render service from Allegheny County to points on and east of U.S. 15 and vice versa, with the right to interchange with Class A, B & D carriers, excluding service to the three counties of Lebanon, Lancaster and Berks.

The record in the ETA application goes into detail as to why the transferor wants to transfer the Folder 2 authority and fractionalize the right to retain (b). There appears to be no explanation in the ETA application or the permanent application for the further fractionalization of the right to grant the applicant (a). Would you please clarify this further fractionalization for us?





Further processing of the application will be suspended pending receipt of the explanation requested. Please submit the information as soon as possible so that further processing of the application is delayed as little as possible.
