The verified statements should be in paragraph form. Each heading contained in the attached minimum outline should be a separate section or paragraph.

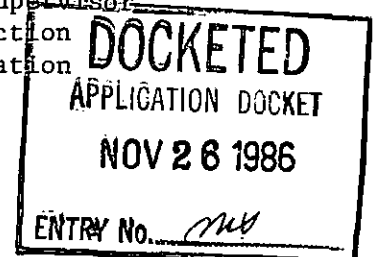
You are being granted an initial thirty (30) days to file verified statements. They will be due on or before December 24, 1986.

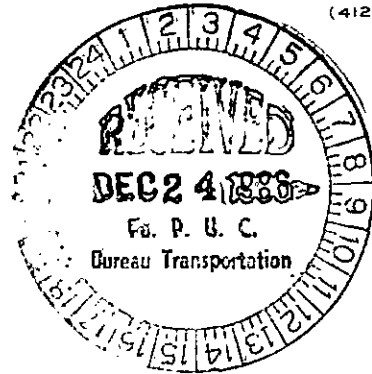

Thank you for your cooperation.

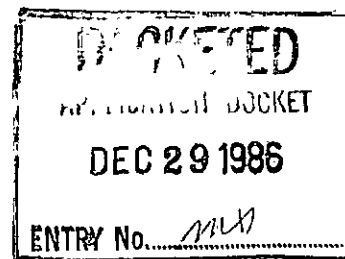
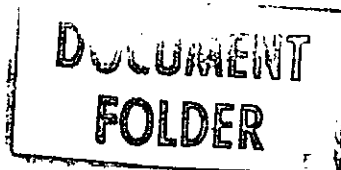
