On behalf of Pitt-Ohio Express, Inc. we have been authorized to amend the above application so as to eliminate service to or from points in the counties of Bradford, Columbia, Lackawanna and Luzerne. As amended, the application will read, in its entirety, as follows:

To transport, as a Class D carrier, property for Atlantic-Pacific Automotive Company from the borough of Mechanicsburg, Cumberland County, to points in Pennsylvania, and vice versa.

Subject to the following condition:

That no right, power or privilege is granted to transport property to or from points in the counties of Bradford, Columbia, Lackawanna and Luzerne.

We understand that the amendment will result in the with-drawal of the protest of Gilchrist Trucking, Inc. and we request that its representative notify the Commission as soon as possible. We also understand that the protests of Central Storage and Transfer Co. of Harrisburg and Pyramid Lines, Inc. will be withdrawn. As a result, the application will be unopposed and we request that it be transferred to the Technical Review Section for further handling without an oral hearing.


