On behalf of Pitt-Ohio Express, Inc., we have been authorized to restrictively amend the above application to read in its entirety as follows:

To transport, as a Class D carrier, property (except commodities in bulk, and household goods and office furniture in use) for Midland-Ross Corporation, from points in the county of Allegheny to points in the counties of Indiana, Clearfield, Cambria, Blair, Huntingdon, Somerset and Bedford, and vice versa.

We have been advised by Albert L. Evans, Jr., the President of Evans Delivery Company, Inc., the sole protestant, that this amendment will satisfy its interests and that upon submission of this amendment he will withdraw the Evans protest. Upon withdrawal of the protest, we request that the application be assigned to the Technical Review Section for disposition without a hearing.



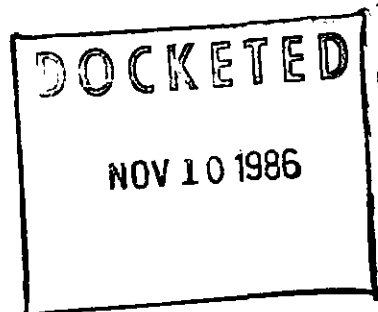
Dear Mr. Rich:
