Dear Mr. Rich:

It is admitted that on October 23, 1986, we handled a shipment from Rockwell International in Uniontown, Pennsylvania, to the State College Borough Authority at State College, Pennsylvania. This shipment consisted of fourteen (14) cartons of metal water meters weighing 563 pounds.

It is denied that this shipment was handled illegally.

This shipment was delivered to Pitt-Ohio Express, Inc. at Pittsburgh, Pennsylvania, on an interline basis. Pitt-Ohio Express, Inc. has the right to interchange and the authority to haul from Pittsburgh, Pennsylvania, Allegheny County, to State College, Pennsylvania, Centre County.

The shipment originated in Uniontown, Pennsylvania, where it was picked up by Hammel's Express, Inc. and hauled to Pittsburgh where it was interlined with Pitt-Ohio Express.

The revenue on that shipment was split by the carriers (see copies attached).


I trust this information will satisfy the Commission and that this complaint will be dropped.


