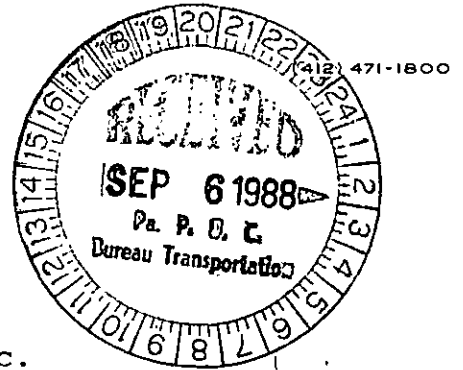

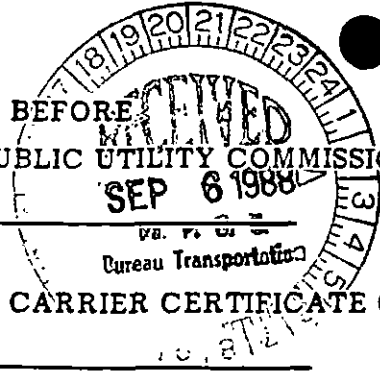

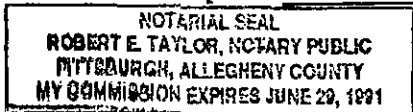

PITT-OHIO EXPRESS, INC.

Scope of Authority Sought

The nature and character of the service to be rendered by Applicant is as follows:

To transport, as a Class D carrier, property (except commodities in bulk and household goods and office furniture in use), for Wagner Division, Cooper Industries, Inc., from its facilities located in the Borough of Fogelsville, Lehigh County, the Borough of Boyertown, Berks County, and the Borough of Weatherly, Carbon County, to points in Pennsylvania, and vice versa.
