Scope of Authority Sought

The nature and character of the service to be rendered by Applicant is as follows:

To transport, as a Class D carrier, property (except commodities in bulk and household goods and office furniture, in use), for Teledyne-McKay, from its facilities located in the city of York, York County, to points in Pennsylvania, and vice versa.
