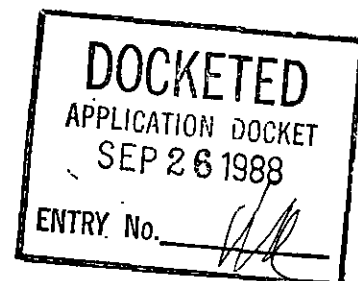

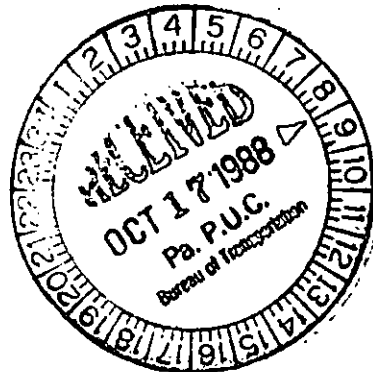

We have been authorized by Pitt-Ohio Express, Inc. to restrictively amend the above application so as to exclude any transportation of shipments weighing 10,000 pounds or more. As amended, the application will read in its entirety, as follows:

To transport, as a Class D carrier, property (except commodities in bulk and household goods and office furniture in use), for Wagner Division, Cooper Industries, Inc., from its facilities located in the township of Upper Macungie, Lehigh County, the Borough of Boyers-town, Berks County, and the Borough of Weatherly, Carbon County, to points in Pennsylvania, and vice versa.

Subject to the following condition:

That the service authorized herein is restricted to the transportation of shipments weighing less than 10,000 pounds.

A copy of this letter has been sent to Mr. Albert L. Evans, Jr., President of West Motor Freight, Inc., the sole protestant. We understand that this amendment will satisfy the interests of West Motor Freight and we ask that Mr. Evans notify the Commission in writing as soon as possible of the withdrawal of the protest. When that withdrawal is received, we ask that the Commission assign the application to the Technical Review Section for further processing without an oral hearing.


