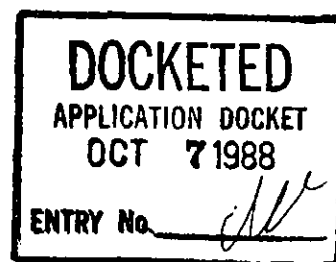

You are being granted an initial thirty (30) days to file verified statements. They will be due on or before December 12, 1988.

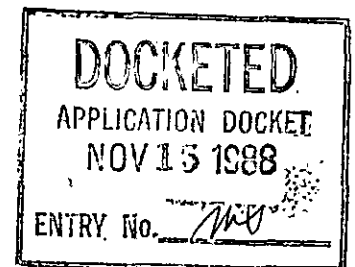
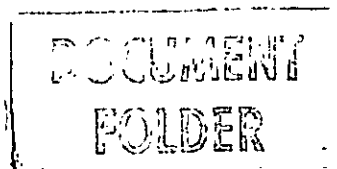
