



(a) Complainant, Jim Lagana, and Respondent, PPL Electric, agree that Complainant will pay his regular monthly bill plus \$99.00 per month toward arrearages, until all arrearages are paid in full, beginning with Complainant's October due date. Complainant and Respondent further agree that Complainant's current monthly budget bill amount will be reduced to \$625.00.

(b) Complainant agrees to withdraw his Complaint.

Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.
