



 - (a) Complainant, Lundes Garrett, and Respondent, PPL Electric, agree that Complainant will pay his regular monthly bill plus \$79.00 per month toward arrearages, until all arrearages are paid in full, beginning with Complainant's November due date. Complainant and Respondent further agree that Respondent will send Complainant an application for the OnTrack customer assistance program.

(b) Complainant agrees to withdraw his Complaint.
