



 - (a) Complainant, Connie Ward, and Respondent, PPL Electric, agree that the fees billed to Complainant's account after her service was terminated will be credited to Complainant's account. The total amount of the credit will be \$65.70, which is composed of \$42.10 for late fees and \$23.60 for customer charges.
 - (b) Complainant agrees to withdraw her Complaint.
