

CERTIFICATE OF SATISFACTION


1. Complainant is Justin Serfass.

 - (a) Complainant, Justin Serfass, and Respondent, PPL Electric, agree that Respondent will apply a credit to Complainant's account in the amount of \$44.77. Complainant and Respondent further agree that Complainant no longer has active service with Respondent. Complainant and Respondent further agree that Complainant will pay \$10.00 per month toward his remaining balance, until the balance is paid in full, beginning on October 30, 2013

(b) Complainant agrees to withdraw his Complaint.
