


4. IGS is continuing to review the publically available portions of the above-captioned filing, and has not yet determined that any specific portion of the filing is harmful or helpful. However, insomuch as the outcome will impact customer rates and tariffs, this matter will impact IGS’s business in the DLC service territory, whether by design or otherwise.

5. IGS will continue to review the documents as this case progresses, including documents which may not currently be publically available, and therefore reserves the right to raise any pertinent issues through testimony, or otherwise, as may be necessary.

6. Because IGS serves customers on the DLC system, and that its service to those customers will be impacted by the above-captioned filing, IGS meets the requirements of 52 Pa. Code § 5.71 *et seq.* with regard to standing to intervene in this proceeding. That is, IGS has a direct and substantial interest that cannot be adequately represented by any other party. Moreover, IGS will be bound by the outcome of this proceeding. Accordingly, IGS has standing to intervene.

WHEREFORE, IGS respectfully requests that the Pennsylvania Public Utility Commission grant its Petition to Intervene and to grant it full party status in the above-captioned matter.


