Reading Metro Taxi Cab, Inc.

ORDER

BY THE COMMISSION:

Reading Metro Taxi Cab, Inc.(carrier) furnishes call and demand service from points in Berks County, as more thoroughly described in the order which grants authority at Docket No. A-00101102.

Carrier has filed Tariff Call and Demand Pa. PUC No. 8 and documentation, in compliance with 52 Pa. Code §§23.63 and 23.68, for passenger carriers with gross annual intrastate revenues of less than \$500,000. The request is certified to the Commission for its decision without an oral hearing. The record consists of the proposed tariff and accompanying documentation.

ANALYSIS

The current rates have been in effect since December 3, 2007. Carrier proposes changing it metered rates as follows:

Increment	1/7 <sup>th</sup> mile	1/6 <sup>th</sup> mile	17%
Flag drop (First increment)	\$2.50	\$2.50	--
Each additional increment	\$.23	\$.30	30%
Each minute waiting time	\$.40	\$.40	--

The carrier reported revenues of \$181,992 for the twelve months ending May 31, 2011. The proposed increase in rates would generate an increase of \$13,368 in revenues for a total projection of \$195,360 for the 12 months following the increase.

There are currently no outstanding fines or assessments. Commission records indicate that the carrier's total intrastate revenue is less than \$500,000 based upon assessment reports. We conclude that the data compiled and submitted by the carrier supports this increase.


**CONCLUSION**
