#### ORDER

#### **BY THE COMMISSION:**

McKean & Burt, Inc., t/a All Ways Moving & Storage (carrier), furnishes household goods in use services originating in Allegheny County and transported distances of 40 miles or less as thoroughly described in the order granting authority.

Carrier has filed the 6th Revised Page 14-A to Tariff Freight Pa. PUC No. 54, on March 24, 2006.

Carrier proposes to increase its flat charge of one hour travel time to and from the job site. Carrier proposes three different rates be applied to travel time to the job site, based upon the miles from the carrier's facilities. The current rates have been in effect since June 30, 2003.

Carrier has submitted a tariff and documentation, in compliance with 52 Pa. Code §23.67(c), for carriers of household goods in use, with gross annual intrastate revenues of less than \$200,000.

### ANALYSIS

In order to generate this revenue increase, carrier proposes to increase the applicable transportation rate assessed. When distance from the carrier's terminal located in Washington, PA is: 1 to 25 miles, travel will be one hour at applicable hourly rates; 26 to 40 miles, travel charge will be one and one-half (1-1/2) hours at applicable rates hourly rates; 41 to 50, miles travel charge will be two (2) hours at applicable hourly rates. Currently, the carrier charges a flat rate of one hour of the applicable hourly rate for travel time. The carrier submitted a statement that its revenues from intrastate operations are less than \$200,000, and its operating ratio is not less than 93%.

## **CONCLUSION**

We have determined that McKean & Burt, Inc., t/a All Ways Moving & Storage, has submitted the documentary justification to support the proposed revenue increase and that the increase is not of an excessive amount based on the operating ratio. We conclude that the increase will be sufficient to provide safe, dependable and continuous service to the public: THEREFORE,

## **IT IS ORDERED:**

- 1. That the 6<sup>th</sup> Revised Page 14-A to Tariff Freight Pa. PUC No. 54, is approved to become effective on May 22, 2006.
- 2. That a copy of this order be served upon the carrier.


