BY THE COMMISSION:

McKean & Burt, Inc., t/a All Ways Moving & Storage (carrier), furnishes household goods in use services originating in Allegheny and Washington Counties as thoroughly described in the order granting authority.

Carrier has filed the 3rd Revised Page 14-C to Tariff Freight Pa. PUC No. 54, on November 29, 2006.

Carrier proposes to increase and decrease certain container and packing charges, which results in a general rate increase for Allegheny and Washington Counties. Current charges range from \$3.00 to \$60.00, submitted proposed charges range from \$1.00 to \$40.00. The current rates have been in effect since April 14, 2003.

Carrier has submitted a tariff and documentation, in compliance with 52 Pa. Code §23.67(c), for carriers of household goods in use, with gross annual intrastate revenues of less than \$200,000.

ANALYSIS

In order to generate this revenue increase, carrier proposes to increase and decrease certain container charges and packaging for Allegheny and Washington Counties. The carrier submitted a statement that its revenues from intrastate operations are less than \$200,000, and its operating ratio is not less than 93%.

CONCLUSION

We have determined that McKean & Burt, Inc., t/a All Ways Moving & Storage, has submitted the documentary justification to support the proposed revenue increase and that the increase is not of an excessive amount based on the operating ratio. We conclude that the increase will be sufficient to provide safe, dependable and continuous service to the public: THEREFORE,
