



(a) Complainant, Brian Helm, and Respondent, PPL Electric, agree that Complainant will make a payment of \$50.00 to Respondent by October 11, 2013. Complainant and Respondent further agree that Complainant will subsequently pay his regular monthly bill plus \$67.00 per month toward arrearages, until all arrearages are paid in full, beginning with Complainant's November due date.

(b) Complainant agrees to withdraw his Complaint.

5.
