on It May Concern:

On August 18, 2011, the Bureau of Transportation and Safety instituted a Complaint against Safder Zaman and Haidri Waheed, T/A American Cab Co. alleging the following:

- Failed to have proper identification markings on each side of vehicle; a violation of 52 Pa. Code §29.71(a)
- Failed to have consumer info decal on vehicle; a violation of 52 Pa. Code §29.318
- Failed to carry a legible, completed log sheet in taxi; a violation of 52 Pa. Code §29.313(c)
- Failed to have a meter in taxi; a violation of 52 Pa. Code §29.314(b)(1)
- Failed to have a dome light on taxi; a violation of 52 Pa. Code §29.314(e)
- Failed to have rates posted; a violation of 52 Pa. Code §29.316(c)

The Bureau of Transportation and Safety notified Safder Zaman and Haidri Waheed, T/A American Cab Co. to file an Answer to the Complaint in accordance with 52 Pa. Code §5.61, within twenty days of the date of the Notice. The Notice further specified that, if it failed to file an Answer to deny the allegations of the Complaint, the Bureau of Transportation and Safety would request the Commission to issue a Secretarial Letter imposing the fine of \$1,450.


The Complaint was sent by Certified Mail on August 22, 2011. A receipt from the U.S. Postal Service indicates that the Complaint was served on September 9, 2011.

More than twenty days have passed and an Answer has not been filed. Therefore, the allegations in the Complaint are deemed to be admitted and the Complaint is hereby sustained.

Safder Zaman and Haidri Waheed, T/A American Cab Co., within twenty (20) days from the date of service of this Order, shall pay a fine of one thousand four hundred and fifty dollars (\$1,450) by certified check or money order payable to the Commonwealth of Pennsylvania sent to the Pennsylvania Public Utility Commission at P.O.

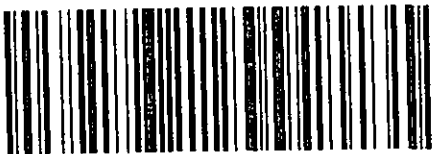
