

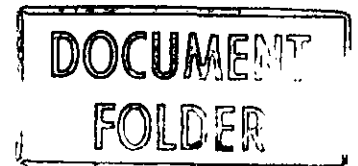
This is to advise that no timely filed exceptions and no requests for review from the Commissioners have been received within the specified time period to the decision issued in the subject case.

A copy of the final order has been enclosed for your records.

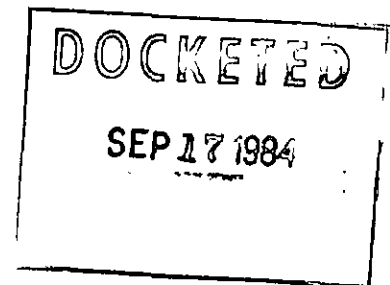

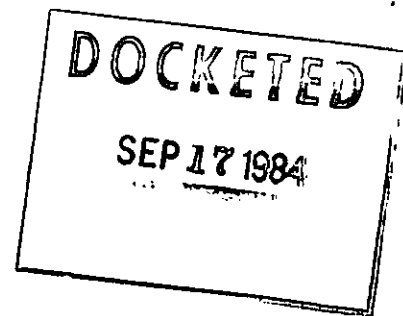

Application of Klapac Trucking Company, a corporation of the Commonwealth of Pennsylvania, for amendment to its common carrier certificate, which granted the right, inter alia, to transport, by motor vehicle, scrap steel, in bulk, in dump vehicles, from the facilities of Universal-Cyclops Specialty Steel and Division, located in the city of Titusville, Crawford County, to points in the borough of Greenville, Mercer County, and vice versa: SO AS TO PERMIT the transportation of property (excluding household goods in use, commodities requiring dump vehicles and shipments weighing less than 10,000 pounds from one consignor to one consignee) (1) between points in the county of Venango, and from points in the said county, to points in Pennsylvania and vice versa; and (2) between points in the city of Titusville, Crawford County and from points in said city to points in Pennsylvania and vice versa.
