

  - (a) Complainant, Sheryl Linard, and Respondent, PPL Electric, agree that Complainant will make a payment of \$122.00 to Respondent by November 6, 2013. Complainant and Respondent further agree that Complainant will subsequently pay her regular monthly bill plus \$20.00 per month toward arrearages, until all arrearages are paid in full, beginning with Complainant's December bill. Complainant and

Respondent further agree that Complainant will be removed from the budget bill program with her current bill.

(b) Complainant agrees to withdraw her Complaint.

Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.
