Due to the fact that our year-end accounting work has not yet been completed, we respectfully request a 30-day extension of time for filing our 1993 Annual PUC Report.

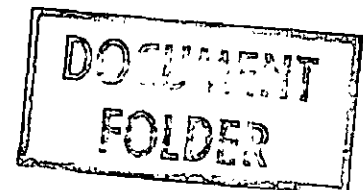


