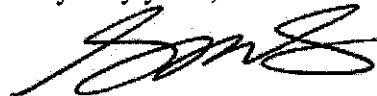

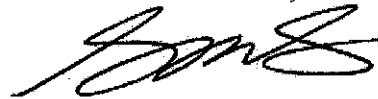
CERTIFICATE OF SATISFACTION

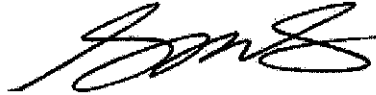
