(a) Complainant, Whitney Depew, and Respondent, PPL Electric, agree that Complainant will pay her regular monthly bill plus \$63.00 per month toward arrearages, until all arrearages are paid in full. Complainant and Respondent further agree that Complainant's first payment of \$130.00 is due on November 6, 2013. Complainant and Respondent further agree that Respondent will waive Complainant's security deposit in the amount of \$292.00. Complainant understands that

this security deposit is being waived as a one-time courtesy, and that the security deposit may be reassessed to her account if she has late payments in the future.

(b) Complainant agrees to withdraw her Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.
