CERTIFICATE OF SATISFACTION

1. Complainant is Sonexay Sanaphol.
2. Respondent is PPL Electric Utilities Corporation (hereafter referred to as "PPL Electric").
3. This Certificate of Satisfaction of Complaint is submitted pursuant to 52 Pa. Code § 5.24(b).
4. PPL Electric hereby certifies that the parties to the above-referenced formal Complaint, now pending before the Pennsylvania Public Utility Commission (hereafter "Commission"), have mutually and voluntarily agreed upon the following terms as full satisfaction of all outstanding legal and factual disputes in this proceeding, and Complainant has acknowledged satisfaction to PPL Electric:
 - (a) Complainant, Sonexay Sonaphol, and Respondent, PPL Electric, agree that Complainant is enrolled in the OnTrack program with a monthly fee of \$155. This OnTrack amount is less than the average monthly budget bill (a budget bill represents 1/12 of the annual bill).

(b) Respondent, PPL Electric, agrees to change Complainant's first bill due date until November 23, 2013. A bill will be issued and due approximately every 30 days thereafter (with such due dates fluctuating a few days before or after the 23rd of each month).

(c) As Complainant has missed his October, 2013 OnTrack payment, Complainant shall pay his November 2013 OnTrack payment of \$155 plus \$50 towards the October arrearage. Thereafter, Complainant shall pay his December 2013 OnTrack payment of \$155 plus \$50 towards the October 2013 arrearage. Complainant will then pay the January 2014 OnTrack payment of \$155 plus \$55 towards the October 2013 arrearage. Upon completion of making the November, December and January payments, the October 2013 arrearage should be paid in full, and Complainant will make the February payment of \$155.

(d) Complainant agrees to withdraw his Complaint.

5. Respondent, PPL Electric hereby notifies Complainant of the filing of this Certificate of Satisfaction, and that if Complainant objects or disagrees with the terms of the Certificate of Satisfaction, Complainant must notify the Commission in writing of their objection and/or disagreement within ten (10) days of the date this Certificate of Satisfaction was signed and served, or the terms of the Certificate of Satisfaction will become final and binding.

WHEREFORE, PPL Electric Utilities Corporation respectfully requests that the docket be marked closed in this matter.
